# **Counterculture History Coalition (CHC) - Jerry Joffe**

Jerry thanked the committee for supporting the project.

He read out the Mission Statement:

# Q&A:

Question: Request for an email contact.

Question: Ann would like to connect with the CHC group. She wrote some academic papers on CounterCulture.

Jerry – The purpose of bringing these folks to the Fair is so that we can interface with them.

Question: What are the parameters / focus of the coalition?

Jerry J. – We are collecting artifacts from the 60's.

Question: What are the plans for this year?

Jerry – We will be at the Magical History Tour Theater. There will be 6 presentations/discussions, 2 each day, at 1 pm and 4 p.m. In between times, the regular video can loop in the theater. At 1 p.m. and 4 p.m. times, we will cover the screen and have a panel discussion and interaction in the theater. Topics for each of the Friday – Sunday sessions are:

- Oregon/Ca. Counterculture Festivals (OCF, folks from s. Oregon).
- Who tells the story Archives and Communities ways to go about it.
- Transatlantic comparison of back-to-the-land movement between France and the PNW
- Multigenerational back-to-the-land movement.
- Maintaining archives
- Panel of Counterculture into the Future (Sunday at 4 p.m.)

We will advertise this in the Peach Pit and include information about the Still Living Room.

A mention: Oregon was the only state that had the Vortex – the state sanctioned rock festival.

Question: What is the mechanism for the CHC to collect information?

Jerry – This group of folks is knowedgable about how to collect information. They will have some flyers and sign up sheets.

Question: Is there a way to send in submissions?

Jerry believes he has passes for this group of folks. Kirsten, our ED, has been highly receptive to the idea. Paxton – Bend in the River – Ken Kesey's project. Paxton can offer a BELLPRO??? With a battery pack for recording the seminars.

A mention: Collection protocol is very important.

Jerry J – There are two conversations here: The nuts and bolts of presenting, and the collecting of stories. Jerry is thinking about obtaining an (Oregon) Cultural Trust grant for collecting stories. Question: How about a pre-fair meetup with these folks?

Jerry – I am taking on the role of logistics. Some of the people coming have never been to the Fair. I am in all kinds of negotiations to work things out for these folks to be here.

CHC has 6 x 6 ft panels displaying topics.

Mention: Invite these CHC folks to the Meet and Greet (resounding "YES" from the meeting attendees). Jerry – It would be nice for everyone to spread the word about the CHC's presence at the Fair.

Mention: How to deal with so many people crowding into the little theater?

Jerry – that will be a good problem to have.

Final words: Darlene expressed appreciation for Jerry's work (meeting attendees agreed).

#### **Board liaison report – Kevin Levy**

The Board is getting prepared for the Fair. Election Bylaws motions are coming up, including bylaws affecting Fair age for membership, voter registration deadline and voter eligibility, the number of signatures required for petitions, and several other modifications.
